## **ITEM 7: ACCEPTANCE OF LEAGUE RULES 2015 / 2016 SEASON**

A FULL VERSION OF THE RULES HAS BEEN CIRCULATED WITH THIS DOCUMENT THE FOLLOWING IS A BREAKDOWN OF WHY OR HOW THEY RULES DIFFER TO THE 2014 / 2015 VERSION.

### **Rule 1(D)**

Date Change to 2015 - 2016

### **Rule 2(D)**

Changed to not adopted as not applicable to this league

### **Rule 8(A)(i)**

This change reflects the amendment to FIFA Regulations on the Status and Transfer of Players, which dictates that an International Transfer Certificate is now required from the age of 10 years old, for any player who is seeking to register with a Club in England and who has previously been registered with a Club abroad (including the other Home Associations), or who is a foreign national seeking to register for the first time in this country.

Competitions should also be aware that there are stringent requirements imposed by FIFA in relation to international clearance for minor players (those under the age of 18).

### **Rule 8(K)**

Last day of transfer of players put back to February in each year and clarified between the date of last registrations. It had been mistakenly changed in typing error two seasons ago when all the rules were changed.

### **Rule 10(B)**

This amendment seeks to address concerns raised regarding children playing matches in two different competitions in one day. The previous Rule did not explicitly prevent this, however it is considered to be to the detriment of player welfare and development. The Rule has therefore now been amended to clarify that the maximum daily playing time stated for each age group applies across all competitions.

### **Rule 10(F) ii**

Changed to not adopted as not applicable to this league

### **Rule 10(G)**

This amendment has been made in response to a number of representations from stakeholders and clarifies that in Mini Soccer, a team may register any number of players during the course of the season, but may not have a match day squad greater than double the size of its team (e.g. for 5v5, 10 players), with the intention being to ensure that players' opportunities for game time is maximised.

### **Rule 10(I)**

Wording changed to better explain what's required in terms of the FA Respect Programme incorporating how a pitch is set up, spectators area one side, coaches the other etc.

### **Rule 11(D)**

Amendment reflecting U11 football now being non-competitive.

### **Rule 12(A)**

Wording changed to add the words "may be determined by deciding match(s) played under conditions determined by the Management Committee" This was omitted in error in previous versions of the rules.

### **SYL Cup Rules - 3(B)**

Amendment reflecting all football up to U11 now being non-competitive.
